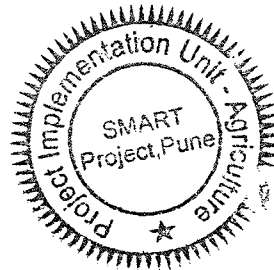

As per the relevant contract clause, the initial contract period is for one year, with extensions granted based on project requirements and the satisfactory performance of the service provider.</p> <p>2. Any extensions provided to the service provider were granted only after obtaining the approval of the competent authority.</p> <p>3. However, to avoid ambiguity, PIU Agri has published new tender to engage service provider for vehicle hiring. The Notice Inviting Tender is enclosed for perusal.</p>
