With reference to your Tender dated 02/07/2017 and financial bid opened on 02/07/2017, we are pleased to inform you that the Competent Authority of MRSAC has approved the award of contract on you for "providing Manpower for Cleaning, Sanitation, Housekeeping and Garden maintenance contract at MRSAC, Nagpur" for a period of one year w.e.f. 1st September, 2017 (Extendable subject to satisfactory Services) on the following terms and conditions and as per the scope of work and terms and condition of the tender.
The monthly contract value for deploying 05 persons sweeper & scavengers (Safal Kamgar) will be Rs. 73470.30 (excluding service tax) @ Rs. 12245.05/- per person/per month as per the breakup of wages in your price bid.

1. The wages to the sweeper and scavengers (Safal Kamgar) should be paid as per minimum wages Act 1948, and other statutory benefits such as EPF & ESIC etc. as per law applicable from time to time. The payment on account EPF, ESIC, included in your breakup of wages is payable. You will have to submit proof of having deposited the amount of EPF, ESIC contribution towards the persons deployed at MRSAC, Nagpur in their respective accounts before submitting the bill withheld till submission of required documents.
2. At the end of the contract you will have to produce "No Dues Certificate" from EPF, ESIC authorities for having met liabilities under these components, otherwise your last bill will be withheld along with the security deposit.
3. You will be responsible to make payments of wages for the month on or before 7th of the succeeding month. You will have to first disburse these wages yourself to sweeper & scavengers (Safal Kamgar) without waiting for the payment from the office which will be reimbursed to you after complying with prescribed requirement.
4. The payment will be made on monthly bill basis within 10 days after receipt of the bill supported with copies of the following:
a) Attendance sheet of labourers for the respective month; b) Wages sheet for respective month; c) Challan of EPF, ESIC.
5. Service tax will be initially paid by you and will be reimbursed by MRSAC, Nagpur on submitting the proof of remittance in the following month.
6. You will have to make payment of wages by drawing account payee of cheque/through ECS/NEFT in the respective accounts of sweeper & scavengers (Safal Kamgar).

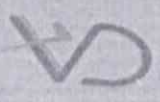
