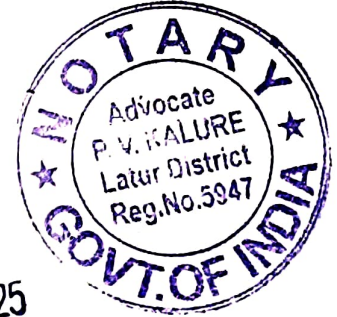

AGREEMENT FOR HIRING OF VEHICLES ON CALL BASIS FOR THE PERIOD OF ONE YEAR FOR TRAVEL AROUND LATUR OR IN MAHARASHTRA

From 11/07/2024 to 10/07/2025

This Contract entered into and executed by and between:

Regional Implementation Unit (SMART), Latur, Behind Old Collector Office, Shivaji Chowk, Latur
And

M/s Affan Car Rental, Bari Colony, Central Naka Road, Chhatrapati Sambhajanagar. (Hereinafter referred as SERVICE PROVIDER)

A. General Terms & Conditions of Contract:

1. All the above quantity rate quoted by you is for evaluation purpose only, but the limit of expenditure for this contract will be decided by the client including all the taxes.
2. The agency shall bear all expenses required for keeping the vehicles in smooth running condition such as fuel, lubrication oil, consumables, necessary spares, maintenance, driver's salary etc.
3. All applicable taxes, permits, license, comprehensive insurance and any other documents for operating the vehicle commercially should be fully paid and should be available in the vehicles.
4. Vehicle may be required any working or Sundays & other holidays on demand.
5. Driver to be provided must possess valid driving license having minimum three years' experience. The agency must submit the photocopies of valid licenses during the use. The drivers of the vehicle must follow traffic rules and other regulations prescribed by the government from time to time.
6. The vehicle must be made available at any given time and day as informed. The vehicle should report to the place of requirement as per directions of the office. The mileage will be counted from client office to client office.
7. The client will not be responsible for any loss, injury, damage or accident to the vehicle or to any other vehicle.
8. The agency should have the arrangements for repairing their vehicle in a short time and during the repair time the agency should provide a substitute vehicle and driver immediately.
9. The telephone facility (24 hours) must be available with the agency. The agency shall pay the Parking charges and/or Toll charges during the travel and the same shall be reimbursed by client to the agency on raising of the monthly bill.
10. Client will pay applicable GST to the agency.
11. Applicable tax would be deducted at source.
12. A penalty of Rs. 2000/- per day may be levied if any vehicle fails to meet above terms and conditions on any day.
13. Rates quoted should be valid for a period of one year from the date of award of contract. No revision in quoted rates on account of increase in fuel charges, spares, taxes etc. will be entertained.
14. The contract will initially be for a period of one years which may be extendable further up to six months to one year on rendering satisfactory services.
15. Agency should take signature on duty slip of concern officer. Any advance will not be paid. Agency will be responsible for drivers lodging, boarding and any other expenses, vehicle expenses during travel.
16. Minimum charges will be paid if running of the vehicle is less than the agreed norms.
17. The agency will abide by all applicable statutory requirements as per Minimum Wage Act, Employee's Provident Fund Act, Workmen Compensation act, Payment of Wages Act, Contract Labour (Regulation and Abolition) Act and motor vehicle Acts. etc.
18. Client will not be responsible or liable in case of any dispute arising between the agency and the drivers employed by the agency and no relationship of Employer and Employee shall come into existence between the Client and the agency or drivers for which all responsibilities shall vest with the agency alone.
19. Client reserves the right to terminate this arrangement without assigning any reasons thereof, by serving on the agency a notice of one month to this effect, and on the refusal of the agency to accept the notice of termination of the arrangement or passive avoidance to do so, the said notice shall be sent by registered post on the address of the agency recorded with the client where after it shall be deemed to have been served to the agency. Client shall also be entitled to appoint any other person, firm or company at its discretion to perform the job entrusted to the agency after termination of the arrangement. Provided that the termination of the arrangement, as aforesaid, shall not absolve the agency of its liability regarding vehicle hiring arrangements already entrusted to it in accordance with the direction of the client.
20. In case of any dispute arising out / relating to interpretation of terms of conditions or functioning of the agency vis-a-vis the client shall be the sole authority to decide the arbitrator in accordance with the Indian Arbitration Act 1940. The agency agrees to execute all documents, which may be required by the client in this regard.

B. Terms and Conditions of Payment:

1. The payment will be made on monthly basis within two weeks from the date of submission of bills duly supported by duty slip(s)/log sheet(s) duly signed by the concerned officers. Applicable GST will be paid on submission of invoice/bill.

A. Termination of Contract: -

19. RIU SMART, Latur reserves the right to terminate this arrangement without assigning any reasons thereof, by serving on the Service Provider a notice of one month to this effect, and on the refusal of the Service Provider to accept the notice of termination of the arrangement or passive avoidance to do so, the said notice shall be sent by registered post on the address of the Service Provider recorded with the RIU SMART, Latur, where after it shall be deemed to have been served on the Service Provider. RIU SMART, Latur shall also be entitled to appoint any other person, firm or company at its discretion to perform the job entrusted to the Service Provider after termination of the arrangement. Provided that the termination of the arrangement, as aforesaid, shall not absolve the Service Provider of its liability regarding vehicle hiring arrangements already entrusted to it in accordance with the direction of the RIU SMART, Latur.

B. Arbitration: -

20. In case of any dispute arising out / relating to interpretation of terms of conditions or functioning of the Service Provider vis-a-vis the RIU SMART, Latur, the RIU SMART, Latur shall be the sole authority to decide the arbitrator. The Service Provider agrees to execute all documents, which may be required by the SMART in this regard proceedings. The proceeding of the arbitration shall be held in Pune in accordance with the Arbitration and Conciliation Act, 1996; or any enactment of the time being made replacing introducing or modifying the same.

C. Amendment:-

21. Except as expressly provided in the Agreement, no modification of the terms and conditions or any of the provisions hereof shall be made except by a written instrument which shall be signed by both Parties hereto.

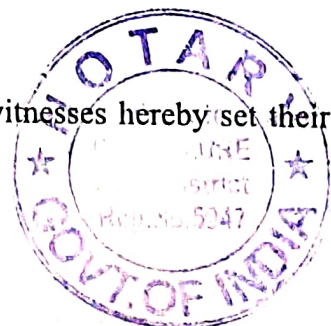
D. Documents:-
