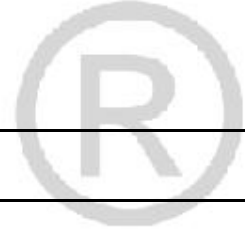

The bristle rollers gently rub the surface of the products and clean it properly. The dirty water accumulates on a water tank fitted below the machine and discharges out continuously. The contact parts will be fabricated from food grade material and structure of mild steel. The machine is fitted with pump.
