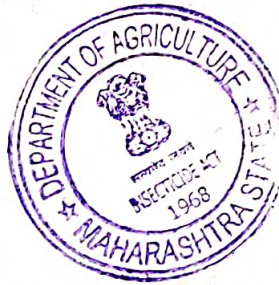
i) The licence shall be displayed in a prominent place in the part of the premises open to the public.
