1st The name of the Company is VIDARBHA NAISARGIK SHETMAL UTPADAK KISAN PRODUCER COMPANY LIMITED

2nd The Registered Office of the Company will be situated in the State of Maharashtra within the jurisdiction of Registrar of Companies, Mumbai.

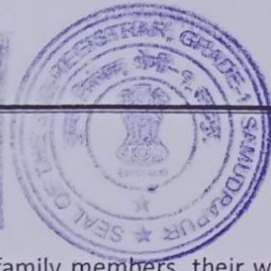
3rd (a) THE OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:

1. To grow, produce, harvesting, procurement manufacture, process, prepare, refine, extract, manipulate, grind, bleach, drying, brewing, listing, delisting, venting, canning, packing, commercialize, marketing, buy, sell, export, import or otherwise deal in all kinds of organic agricultural, horticultural, floriculture, viticulture, AP Culture, PC Culture, Aquaculture, Cerry Culture, Medicinal Plant and its bye products, Lac Cultivation, Gum Cultivation, Forest Bye product for converting into oils and bye product, Poultry Farming, goat Farming, cottage products, farm produce and products including food grains, cereals, seeds, plants, flowers, vegetables, fruits, pulses, oil seeds, milk & milk products and good products and preparation of any nature in India and abroad.

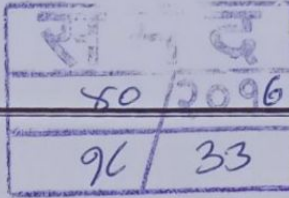
(b) MATTERS WHICH ARE NECESSARY FOR FURTHERANCE OF THE OBJECTS SPECIFIED IN CLAUSE 3 (A) ARE:

2. To promote techniques of mutuality and mutual assistance;
3. To produce, sell, allot and give on lease, exchange or supply machinery, equipment or consumables mainly to its members for the attainment of the main objects of the Company.
4. To provide, render, arrange for imparting education on the mutual assistance principles to its members and others;
5. To render, provide, arrange for providing technical services, consultancy services, training, research and development and all other activities for the promotion of the interests of its members and others.
6. Transmission and distribution of power, revitalization of resources, their use conservation and communications relatable to primary produce of the members and other organic producers.

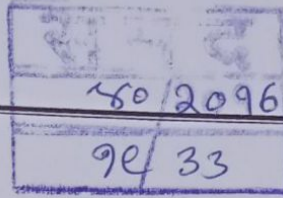


7. To enable producers to get insurance for themselves, their family members, their wealth and other assets and their primary produce.
8. To undertake welfare measures or facilities for the benefit of members as may be decided by the Board and to promote employment generation for women in rural or urban areas and to improve their status in the society.
9. To undertake organic production program, processing, certification of the products produced by members and other organic producers.
10. To promote thrift and credit facilities among its members and to organize those into self-help groups.
11. To enter into such contracts or arrangements as the company may think fit for the social and economic upliftment of members.
12. To provide finance production, procurement, processing, marketing which including extending credit facilities and other services to its members.
13. To design, fabricate, erect, build, run, manage, arrange and maintain godowns, warehouses, agro malls, show-rooms, shops, laboratories, special chambers required for the activities of the Company.
14. To enter into contracts, agreements, and arrangements, with any other Company, firm, trust, government, society, organisation, institution, authority, concern or individual for attainment of the objects of the company.
15. To promote, form and aid in the promotion, formation of any company or companies having similar objects for the purpose of acquiring all or any of the property, rights and liabilities of this company and to transfer to any such company any property of the company, and to be interested in, or take or acquire, hold, sell or otherwise dispose of shares, stock, debentures and other securities in and to subsidise or otherwise assist any such company.
16. To purchase, hire or acquire and maintain suitable buildings, ownership flats, apartments, furniture and other fittings for the purpose of achieving any of the objects for which the company is established and to construct, alter or keep in repair any buildings, flats or premises required or used by or for the company, in connection with its business or for use by its employees.
17. To sell, improve, manage, develop, exchange, loan lease or let, under-lease, sub-let, mortgage, dispose of, turn to account or otherwise deal with any property of the company.
18. To advance money with or without securities to such companies, firms or persons, and on such terms as may seem expedient and in particular to the customers and others having dealings with the Company and to guarantee the performance of contracts by any persons,



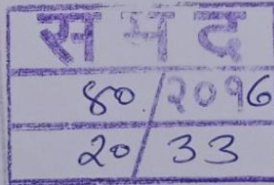
firms or companies. Provided that the Company shall not carry on the Banking Business as defined under the Banking Regulation Act, 1949.

19. To amalgamate, divide, merge, compromise and collaborate with and to takeover any Company or firm, proprietorship firm having similar objects or to enter into Partnership, Joint Venture or other arrangement, reciprocal concession with any person or company, firm or other organisation and undertaking.
20. To apply for, promote, obtain, protect and deal in any patent, patent right, copy right, trade mark, formulas, designs, licenses and concessions conferring any right.
21. To establish, provide, maintain, run and close library, trust, research institution, centre, society, company, firm, workshop (with permission of appropriate authority wherever required) and to arrange meetings, lectures, seminars, get together, social functions, conferences for the interest of general public or any section thereof and to run training institutions for promotion of the objects of the Company.
22. To make or accept Gift, bequests, donations, awards, prizes, scholarships, fellowships and grants to or from deserving persons, institutions, political parties, Government, organisation and establishments.
23. To borrow and receive money and to draw, make, accept, endorse, discount, execute and issue negotiable instruments, debentures, deposit receipts, and acknowledgments on such terms and conditions as may be thought fit.
24. To distribute among the members of the Company any property of the Company in the event of winding up.
25. To appoint, remunerate and remove any directors, trustees, employees, executives, experts, consultants, and retainers of the business of the Company.
26. To train or pay for the training in India or abroad of any member or any of the Company's employees or directors or any other candidates in the interests of and for the furtherance of the company's business.
27. To start maintain subsidized or contribute to charitable dispensaries or hospitals, gymkhanas, play grounds, clubs, libraries, technical institutions for the benefit of the public or as to promote the Company's interest.
28. To mortgage, charge, sale or otherwise dispose off any property of the Company as may be thought expedient in the interest of the Company.
29. To sublet and / or assign contract, properties, right as may be thought expedient.
30. To agree to arbitration and refer to arbitration any disputes and to initiate and institute and settle or take legal action and proceedings in connection with the business of the Company and to defend the suits filed against the Company.







31. To build, construct, alter, maintain, enlarge, pull down remove or replace and work, manage and control any building, roadways, and other conveniences for attainment of main object of the Company.

37. To undertake and execute job works, which is within the object resources of the Company.
38. To provide for the welfare of employees, or ex-employees of the Company and the wives and the families or the dependents of such persons, by building or contributing to the building of houses, dwellings or chawls or by grants of money, pensions, allowances, bonus or other payments or by creating and from time to time subscribing or contributing to provident and other associations, funds, or trusts and by providing or subscribing or contributing towards places of instruction and recreation, hospitals and dispensaries, medical and other attendance, and other assistance as the Company shall think fit.
