No claim for any modification will be entertained post delivery.
10	Payment Terms	50% advance along with the Purchase order and 50% after inspection before dispatch in the name of NIDO Machinerries Pvt. Ltd. an account payee cheque / draft payable at Mumbal, Maharashtra. In case of cancellation of a confirmed order for any reason whatsoever, 25% of the order value shall have to be paid by you to us, as damage. 12	MSME STATUS	Nido Machinerries Private Limited - Registered under the Micro, Small and Medium Enterprises Development Act, 2006 We wish to inform you that we, Nido Machinerries Private Limited are registered under the Micro, Small and Medium Enterprises Development Act, 2006 ("MSMED Act, 2006") and we would like to draw your attention to some of the significant provision of MSMED Act, 2006 which are as follows :- Section 15 of the MSMED Act 2006, provides that any buyer who buys goods or avall services from a MSMED registered enterprise is required to make payments within 45 days of the said transaction. In the event of any delay in payments as per Section 16 of MSMED Act, 2006, buyer shall be liable for payment of compound interest in three times the bank rate notified by Reserve Bank of India. As per Section 22 of MSMED Act, 2006, buyer is required to explicitly disclose in its books of accounts the amount due to a MSMED registered entity along with the interest payable thereto.
