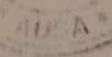
1st The name of the company is "KETAKISANGAM AGRO PRODUCER COMPANY LIMITED".

A) The objects to be pursued by the company on its incorporation are: -

1. To manufacture, process, prepare, preserve, refine, bottle, buy, sell and deal whether as wholesaler or retailers or as exporters or importers or as Principals or agents or as keepers or dealers in all kinds of milk products, including Cheese, Butter, Ghee, Ice creams, Baby foods, Instant foods and any by-products or co-products thereof and to carry on the business and setting up of Dairy Farms, Milk Processing Plants, Food Processing Plants, Cold Storage Plants, Research laboratories, Packing units, Bottling Plants and to manufacture and deal in all kinds and varieties of foods for human or animal consumption and to carry on the business of production, procurement, marketing, processing, storage, bottling, packing, distribution and trading of all agricultural, horticultural, vegetables, medicinal, spices crops, agro-produce, floriculture, medicinal plants, Handicrafts, cow rearing, Goshala, Beekeeping, transportation and trading of all Agro inputs like Seeds, Manure, fertilizers, pesticides, farm machinery and farm tools.
