INVITATION FOR QUOTATIONS

Sub : Invitation for quotation for VCDS Maize Crop Demo Inputs.

Dear Sir/Madam

1. Government of Maharashtra has launched World Bank assisted "Hon. Balasaheb Thackeray Agribusiness & Rural Transformation (SMART) Project" in the State of Maharashtra in order to transform agriculture and livelihoods sector in Maharashtra. The objective of the project is "to support development of inclusive and competitive agriculture value chains focusing on small holder farmers and agri-entrepreneurs in Maharashtra". This would be achieved by expanding access to new and organized markets for producers and enterprises with complementary investments in provision of technical services and risk management capabilities.
2. Head, District Implementation Unit, Pune, Hon. Balasaheb Thackeray Agribusiness & Rural Transformation (SMART) Project now invites competitive quotation for the following goods.

3. Bid Price

- a) The contract shall be for the full quantity as described above.
- b) All duties, taxes and other levies payable on the raw materials and components shall be included in the total price.
- c) The rates quoted shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- d) Rate should be inclusive of supply to the destination as per the requirement of respective CBO.
- e) Bidder should quote rate all items together.

- f) Supply order of above items will be given within fund limit and financial norms of the smart project.

4. Validity of Quotation

Quotation shall remain valid for a period not less than 60 days after the deadline date specified for submission.

5. Eligibility Criteria:

- a) The bidder must have successfully supplied similar or equivalent item of value *Rs. 0.98 Lakh* in any one year during last three financial years i.e. 2019-2020, 2020-21, 2021-22 Or 2020-21, 2021-22, 2022-23.
- b) Bidder should be registered under Goods and Services tax Act, 2017
- c) Bidder should have its main or branch office anywhere in Dist. Pune, Maharashtra
- d) Bidder should have achieved in at least one year an annual financial turnover not less than *Rs. 2.46 Lakhs* in the last three financial years.
- e) The bidder should not be blacklisted /banned by any Government organization/PSUs during last 3 years.
- f) The Bidder should have all necessary Licence/Sanction to sale above items.

6. Documents to be submitted along with the quotation:

The bidder should submit following documents along with the quotation

- a) PAN Card copy
- b) GST registration certificate
- c) Bid security declaration (in attached format)
- d) Turn over certificate issued by the chartered Accountant/ITR Copy/Balance sheet
- e) Supply orders and installation reports/invoice copies (with respect to clause 5a)
- f) Authorised Licence Copy of Insecticide, seed and Fertilizer should be enclosed
- g) The declaration that the bidder is not black listed/banned by any government organization/PSUs. (in attached format)

7. Bid Security :

- 1) Bidder should submit bid security declaration in the attached format. If bidder not submitted bid security declaration, in such case the bid submitted by such bidder shall be rejected.
- 2) The Bid Security declaration shall be executed
 - a) if a bidder withdraws its bid prior to the expiry date of bid validity specified by the bidder on the letter of bid or any extended date provided by the bidder; or
 - b) During the bid process, if any information submitted found manipulated / hidden /false / mala fide in the bid
 - c) if the successful Bidder fails to
 - (i) sign the Contract or
 - (ii) furnish a Performance Security

8. Delivery period and Place:

Successful bidder should complete supply of goods within 3 days from the date of supply order to **Parnerkar Agrotech (Mahacorn Food) Farmer Producer Company Ltd, Nirvangi Tq.Indapur , Dist. Pune**. If bidder fail to supply of goods within the period, liquidated damage @ 0.5% per week shall be deducted from final payment subject to maximum (10%). Once the maximum deduction is reached, the Purchaser may terminate the Contract.

9. Warranty: *Expiry date of all goods should be more than 3 month at the date of supply.
(Which is printed on product)*

10. General Conditions:

- a) Bidder should submit only one quotation
- b) All legal disputes relating to the supply and installation etc. are subject to the jurisdiction of court of law at Pune District.

11. Evaluation of Quotations

The SMART Project will evaluate and compare the quotations determined to be substantially responsive i.e which

- (a) are properly signed; and
- (b) conform to the terms and conditions, and specifications.

The Quotations would be evaluated for all items together. GST cost shall not be considered in evaluation.

12. Award of contract

The SMART Project will award the contract to the bidder who has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- a) Notwithstanding the above, the SMART Project reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- b) The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply/ work order.

13. Payment:

Payment will be made within 4 weeks after successful supply and installation of goods certified by the authority appointed by the Project along with the bill/invoice. Applicable GST will be paid on submission of invoice/bill.

14. Quotation Submission:

- a. Interested bidder should submit only one quotation in a sealed envelope boldly superscript as quotation for Purchase of Maize crop Demo Inputs **latest by 11.00 AM on 22/06/2023** to *District Implementation Unit, SMART Project, 2nd Floor, Krushi Bhavan, Shivajinagar, Pune-411005.*
- b. Quotations received after due date and time for whatever reason shall not be considered and shall be rejected.
- c. Please quote the lowest possible rate. No negotiations will be entertained
