OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. Bidders are bound to accept the orders accordingly.

5. Annual Turnover Certificate should be submitted from reputed CA.

8. At least 1 work order copy attached with bid for similar product
9. All terms and conditions must be providing by Seller else he should be rejected.
10. If Seller upload un-necessary documents the Seller will be disqualified, so only the necessary and appropriate documents should be upload.
