1. Government of Maharashtra has launched World Bank assisted “Hon. Balasaheb Thackeray Agribusiness & Rural Transformation (SMART) Project” in the State of Maharashtra in order to transform agriculture and livelihoods sector in Maharashtra. The objective of the project is “to support development of inclusive and competitive agriculture value chains focusing on smallholder farmers and agri-entrepreneurs in Maharashtra”. This would be achieved by expanding access to new and organized markets for producers and enterprises with complementary investments in provision of technical services and risk management capabilities.
2. You are invited to submit your sealed competitive quotation for supply and installation of ONE Server as per the details mentioned in annexure A
3. **Bid Price**
 - a) The contract shall be for the full quantity as described above.
 - b) The rates quoted shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
 - c) The Prices shall be excluding GST.
 - d) Rate should be inclusive of supply and installation
4. **Validity of Quotation**

Quotation shall remain valid for a period not less than 45 days after the deadline date specified for submission.
5. **Eligibility Criteria:**
 - a) Bidder should be registered under Goods and Services tax Act, 2017
 - b) The bidder must have successfully supplied at least one similar item for the quoted items during last three years.
 - c) The bidder should not be blacklisted /banned by any Government organization/PSUs during last 3 years.
 - d) Bidder should have its main or branch office anywhere in Maharashtra
6. **Documents to be submitted along with the quotation:**

The bidder should submit following documents along with the quotation

 - a) GST registration certificate
 - b) Supply order with respect to clause 5b

- c) Technical Specification compliance sheet along with brand name and model no for the items quoted.
- d) The declaration that the bidder is not black listed/banned by any government organization/PSUs.
- e) Bid security declaration

7. Delivery and Installation:

Successful bidder should complete supply and installation of goods within 1 week from the date of supply order to Hon. Balasaheb Thackeray Agribusiness & Rural Transformation (SMART) Project, Sheti Mahamandal Bhavan, 270, Bhamburda, Senapati Bapat Road, Pune-411016. If bidder /bidders failed to deliver goods within the time, liquidated damage @ 0.5% per week shall be deducted from final payment.

- c) All legal disputes relating to the supply and installation etc. are subject to the jurisdiction of court of law at Pune.

The SMART Project will evaluate and compare the quotations determined to be substantially responsive i.e. which

- a. are properly signed; and
- b. Conform to the terms and conditions, and specifications.

10. Award of contract

The SMART Project will award the contract to the bidder/bidders' who has been determined to be substantially responsive and who has offered the lowest evaluated price (L1) for the item.

- a. Notwithstanding the above, the SMART Project reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- b. The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply/ work order.

11. Payment:

Payment will be made within 2 weeks after successful supply and installation of goods and warrantee certificate/document issued by the manufacture certified by the authority appointed by the Project along with the bill/invoice and warrantee certificate/document issued by the manufacture. Applicable GST will be paid on submission of invoice/bill.
