1. Government of Maharashtra has launched World Bank assisted "Hon. Balasaheb Thackeray Agribusiness & Rural Transformation (SMART) Project" in the State of Maharashtra in order to transform agriculture and livelihoods sector in Maharashtra. The objective of the project is "to support development of inclusive and competitive agriculture value chains focusing on smallholder farmers and agri-entrepreneurs in Maharashtra". This would be achieved by expanding access to new and organized markets for producers and enterprises with complementary investments in provision of technical services and risk management capabilities.
2. DIU YAVATMAL, Hon. Balasaheb Thackeray Agribusiness & Rural Transformation (SMART) Project now invites competitive quotation for the following GOODS.

**3. Bid Price**

- a) The contract shall be for the full quantity as described above.
- b) All duties, taxes and other levies payable on the raw materials and components shall be included in the total price.
- c) The rates quoted shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- d) The Prices shall be excluding GST.
- e) Rate should be inclusive of Transport and labor charges.
- f) Bidder should quote rate for all the items or any of the item.

#### 4. Validity of Quotation

Quotation shall remain valid for a period not less than 60 days after the deadline date specified for submission.

#### 5. Eligibility Criteria:

Bidder should be registered under Goods and Services tax Act, 2017.

Bidder should have its main or branch office anywhere in Maharashtra.

Bidder should have achieved in at least one year an annual financial turnover not less than Rs. 2 lakhs in the last three financial years.

The bidder should not be blacklisted/banned by any Government organization/PSUs during last 3 years.

#### 6. Documents to be submitted along with the quotation:

The bidder has to submit following documents in the technical envelope.

1. PAN Card copy

2. GST registration certificate

3. Bid security declaration (in attached format)

4. Turn over certificate issued by the chartered Accountant/ITR Copy /Balance sheet.

5. The declaration that the bidder is not black listed/banned by any government organization/PSUs. (In attached format).

6. Insecticide License copy issue by competent authority.

#### 7. Bid Security:

1) Bidder should submit bid security declaration in the attached format. If bidder not submitted bid security declaration, in such case the bid submitted by such bidder shall be rejected.

2) The Bid Security declaration shall be executed

a) if a bidder withdraws its bid prior to the expiry date of bid validity specified by the bidder on the letter of bid or any extended date provided by the bidder; or

b) During the bid process, if any information submitted found manipulated / hidden /false / mala fide in the bid

c) if the successful Bidder fails to

(i) sign the Contract or

(ii) furnish a Performance Security

#### 8. Delivery period and Place:

Successful bidder should complete supply of goods within 7 days from the date of award of contract /supply order to **Delivery Place TAO office - Pandharkawada (60 Nos ), Ralegaon (30 Nos) Darwa (30 Nos), Yawatmal (30 Nos) , Ner (30 Nos) Ghatanji (30 Nos) ,Kalamab( 30 Nos) ,Arni (30 Nos) and Babhulgaon (30 Nos) )** with labour charges and transport. If bidder fail to supply and installation of goods within the period, liquidated damage @ 0.5% per week shall be deducted from final payment subject to maximum (10%). Once the maximum deduction is reached, the Purchaser may terminate the Contract.

## 10. General Conditions:

- The quantity mentioned may increase/decrease depend on the requirement.
- All legal disputes relating to the supply are subject to the jurisdiction of court of law at *Yavatmal*.
- Materials should not be assembled.

## 11. Evaluation of Quotations

The SMART Project will evaluate and compare the quotations determined to be substantially responsive i.e. which

- (a) are properly signed ; and
- (b) conform to the terms and conditions, and specifications.

The Quotations would be evaluated for all items separately GST cost shall not be considered in evaluation.

## 12. Award of contract

The SMART Project will award the contract to the bidder who has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- a) Notwithstanding the above, the SMART Project reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- b) The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply/ work order.

## 13. Payment:

Payment will be made within 4 weeks after successful supply and certified by the respective Taluka Agriculture officer along with the bill/invoice The bill /invoice should be in the name of **"DIU SMART YAVATMAL"** Applicable GST will be paid on submission of invoice/bill.

## 14. Quotation Submission:

- a.
