1. Government of Maharashtra has launched World Bank assisted "Hon. Balasaheb Thackeray Agribusiness & Rural Transformation (SMART) Project" in the State of Maharashtra in order to transform agriculture and livelihoods sector in Maharashtra. The objective of the project is "to support development of inclusive and competitive agriculture value chains focusing on smallholder farmers and agri-entrepreneurs in Maharashtra". This would be achieved by expanding access to new and organized markets for producers and enterprises with complementary investments in provision of technical services and risk management capabilities.

3. Bid Price

- a) The contract shall be for the full quantity as described above.
- b) All duties, Toll, Road taxes, transport to CBO destination (Hingoli, Kalamnuri, Aundha Na. & Vasmath) and other levies payable shall be included in the total price.
- c) The rates quoted shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- d) The Prices shall be excluding GST.
- e) Bidder should quote rate for all the Items.

4. Validity of Quotation

Quotation shall remain valid for a period not less than 30 days after the deadline date specified for submission.

5. Eligibility Criteria:

- a) The bidder must have successfully supplied 7.55 Lakhs quantity in any one year during last three financial years. (2019-20,2020-21,2021-22)
- b) Bidder should be registered under Goods and Services tax Act, 2017
- c) Bidder should have Govt. License of Pesticide Issued by District Superintending Agriculture Officer
- d) Bidder Should have achieved in at least one year an annual financial turnover not less than Rs. 18.94 Lakhs. In the last three financial Years.
- e) The bidder should not be blacklisted/banned by any Government organization/PSUs during last 3 years.

6. Documents to be submitted along with the quotation:

The bidder should submit following documents along with the quotation

- a) PAN Card Copy
- b) GST registration certificate
- c) Bid Security declaration (in Attached Format)
- d) Turn over certificate issued by the chartered Accountant/ITR Copy/Balance sheet
- e) Agency Should submit compliance Sheet along with the quotation on agencies letter head. (In Attached format)

7. Bid Security :

- 1) Bidder should submit bid security declaration in the attached format. If bidder not submitted bid security declaration, in such case the bid submitted by such bidder shall be rejected.
- 2) The Bid Security declaration shall be executed
 - a) if a bidder withdraws its bid prior to the expiry date of bid validity specified by the bidder on the letter of bid or any extended date provided by the bidder; or
 - b) During the bid process, if any information submitted found manipulated / hidden /false / mala fide in the bid
 - c) if the successful Bidder fails to
 - (i) sign the Contract or
 - (ii) furnish a Performance Security

8. Delivery period and Place:

If bidder fail to supply and installation of goods within the period, liquidated damage @ 0.5% per week shall be deducted from final payment subject to maximum (10%). Once the maximum deduction is reached, the Purchaser may terminate the Contract.

9. **Warranty:** Testing Report should be provided with bills of all lots of input supplied. The Warranty of the Inputs should be valid up to 6 months.

10. General Conditions:

- The quantity mentioned may increase/decrease depend on the requirement
- All legal disputes relating to the supply of inputs are subject to the jurisdiction of court of law at Hingoli.
- All the Rights of reserved to reject if any items of tender OR a tender OR all the tender without assigning any reason therefore, decision for acceptance OR rejection rest with the Chief DIU SMART Cum Project Director ATMA Hingoli.
- if any issue raised regarding this tender then it should comes under jurisdiction of Hingoli disrtict court.

11. Evaluation of Quotations

The SMART Project will evaluate and compare the quotations determined to be substantially responsive i.e. which

- are properly signed; and
- conform to the terms and conditions, and specifications.
- Quoted rates for all items.
- submitted all required documents as per clause 5 above.

The Quotations would be evaluated for all items together. GST cost shall not be consider in evaluation.

12. Award of contract

The SMART Project will award the contract to the bidder/bidders' who has been determined to be substantially responsive and

- 1) who has offered the lowest evaluated price (L1) for the separate item wise i.e. Per items amount of the financial quote.
- a) Not with standing the above, the SMART Project reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- b) The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply/ work order.

13. Payment:

Payment will be made within 4 weeks (As per Availability of funds)after successful supply of goods certified by the authority appointed by the Project along with the bill/invoice. Applicable GST will be paid on submission of invoice/bill.


14. Quotation Submission:


