1. Government of Maharashtra has launched World Bank assisted “Hon. Balasaheb Thackeray Agribusiness & Rural Transformation (SMART) Project” in the State of Maharashtra in order to transform agriculture and livelihoods sector in Maharashtra. The objective of the project is “to support development of inclusive and competitive agriculture value chains focusing on smallholder farmers and agri-entrepreneurs in Maharashtra”. This would be achieved by expanding access to new and organized markets for producers and enterprises with complementary investments in provision of technical services and risk management capabilities.

**1. Bid Price**

- a) The contract shall be for the full quantity as described above.
- b) All duties, taxes and other levies payable on the raw materials and components shall be included in the total price.
- c) The rates quoted shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- d) The Prices shall be excluding GST.
- e) Rate should be inclusive of supply & transportation.

**2. Validity of Quotation**

Quotation shall remain valid for a period not less than 60 days after the deadline date specified for submission.

**3. Eligibility Criteria:**

- a) Bidder should be registered under Goods and Services tax Act, 2017
- b) Bidder should have its main or branch office anywhere in Maharashtra
- c) The bidder should not be blacklisted/banned by any government organization/PSU's during last three years.
- d) The bidder must have successfully supplied Fertilizer/Urea Briquettes 21 Tonne, Nano Urea 144 Liters, SSP 1.2 Tonne, MOP 0.8 Tonne in any one year during last three financial years. i e 2020-21, 2021-22, 2022-23 OR.
- e) The bidder must have successfully supplied similar item of value 5.20 Lakh in any one year during last three financial year i. e. 2020-21, 2021-22, 2022-23.

- f) Bidder should have achieved in at least one year an annual financial turnover not less than Rs. 13 Lakh @ in the last three financial years i e 2020-21, 2021-22, 2022-23

**4. Documents to be submitted along with the quotation:**

**5. Bid security**

1. Bidder should submit bid security declaration in the attached format. If bidder does not submit bid security declaration, In such case the bid submitted by such bidder shall be rejected.
2. The Bid Security declaration shall be executed
  - a. if a bidder withdrawn its bid prior to the expire date of bid validity specified by the bidder on the letter of bidder any extended date provided by the bidder; or
  - b. During the bid process, if any information submitted found manipulated/hidden/false/mala fide in the bid

    1. sign the contract or

**7. Warranty:** The validity of the inputs should be up to six months.

**8. General Conditions:**

- Bidder should submit quotation separately.
- The quantity mentioned may increase /decrease depend on the requirement.
- All legal disputes relating to the supply and installation etc. are subject to the jurisdiction of court of law at Gondia.

**9. Evaluation of Quotations**

The SMART Project will evaluate and compare the quotations determined to be substantially responsive i.e. which

- Are properly signed ; and
- conform to the terms and conditions, and specifications.

The Quotations would be evaluated for each item separately. GST cost shall not be considered in evaluation.

**10. Award of contract**

The SMART Project will award the contract to the bidder who has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- Notwithstanding the above, the SMART Project reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotation at any time prior to the award of contract.
- The bidder whose bid is accepted will be notified for the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply/ work order.

**11. Payment:**

A sample of each agricultural input will be taken and payment will be paid after said sample passes the inspection (As per Availability of funds) and also payment will be made after successful supply of goods certified by the authority appointed by the Project along with the bill/invoice. Applicable GST will be paid on submission of invoice/bill.
