The objective of the project is "to support development of inclusive and competitive agriculture value chains focusing on smallholder farmers and agri-entrepreneurs in Maharashtra". This would be achieved by expanding access to new and organized markets for producers and enterprises with complementary investments in provision of technical services and risk management capabilities.

- b) The bidder should not be blacklisted / banned by any Government organization / PSUs during last 3 years.
- c) Bidder should have its main or branch office anywhere in Maharashtra

c) All legal disputes relating to the supply and installation etc. are subject to the jurisdiction of court of law at Latur District.

**18 Evaluation of Quotations:**

- The SMART Project will evaluate and compare the quotations determined to be substantially responsive i.e. which
- (a) are properly signed; and  
(b) conform to the terms and conditions, and specifications.  
The Quotations would be evaluated for all items together. GST cost shall not be considered in evaluation.

**19 Award of contract:**

The Regional Implementation Unit, SMART Project, Divisional Joint Director of Agriculture, Latur - 413512 will award the contract to the bidder who has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- a) Notwithstanding the above, the Regional Implementation Unit, SMART Project, Divisional Joint Director of Agriculture, Latur - 413512 reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.  
b) The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply / work order.
